SUB: 18TH NATIONAL JAMBOREE DECISION DURING STATE ORGANISING COMMISSIONER'S MEET HELD AT PALI, RAJASTHAN ON 16TH AND 17TH NOVEMBER, 2022

Dear Sir/Madam,

The SOC's meet was held at Pali, Rajasthan on 16th & 17th November, 2022 in conjunction to the preparations for the ensuing 18th National Jamboree scheduled to be held at RIICO (DMIC) area at NH- 62, Rohat, District: Pali, Rajasthan from 04th to 10th January, 2023. On the unanimous proposals of the SOC's present in the meeting, following decisions were made and ensured by all the SOC's to complete all the pending issues related to 18th National Jamboree on a time bound manner meticulously.

- 1. REGISTRATION OF PARTICIPANTS IN THE GOOGLE SPREAD SHEET:** The registration of participants to complete in the Google spread sheet is further extended upto 25/11/2022. All the SOC's present in the meeting ensured to complete the registration process on or before **25/11/2022** and no further extension will be considered. It was also unanimously decided that State who fail to register within the extended deadline, their quota will be provided to other aspiring State Association.
- 2. REMITTANCE OF SCOUT/GUIDE WELFARE FUND:** It was unanimously agreed by the SOC's that the Scout/Guide welfare fund will be remitted in NHQ account by the respective states on or before **25/11/2022**. Later on late fee will be charged if needed.
- 3. REQUISITION OF BUS, TRUCK/TEMPO:** The SOC's further committed that requisition of Bus, Truck/Tempo from the Railway Station upto Jamboree site and back will be submitted to the Jamboree authority in the proforma provided vide NHQ Circular No. 214/2022 dated 04th November, 2022 latest by 25/11/2022. It was unanimously agreed in the meeting that State Association who fail to submit the requisition of Bus, Truck/Tempo to the Jamboree authority within **25/11/2022** will arrange their own local transportation and the Jamboree authority should not be held responsible.
- 4. REQUISITION OF MATERIALS REQUIRED FOR THE STATE CONTINGENT:** It was decided in the meeting that State Association who requires materials like Ballies, Bamboos, Gas

burner/Chula, Chairs, Tables, Mattress, blankets or any other materials on payment basis are requested to submit their requisition to Jamboree Secretary, The Bharat Scouts and Guides, State Headquarters, Jawahar Lal Nehru Marg, Bajaj Nagar, Jaipur – 302015 (Rajasthan) at email jamboreeoffice@bsgindia.org with a copy to jamboree@bsgindia.org on or before **30/11/2022** so that necessary arrangements can be made by the Jamboree authorities and can be communicated to the State Association. Requisition submitted after 30/11/2022 will not be entertained. **Please ensure to submit the size of the ballies & Bamboos, thickness of the rope, sutli's so that actual materials required by the States can be made available by the host State Association.**

5. **BUS FOR SIGHTSEEING:** State Contingent interested to avail sightseeing are requested to submit the duly filled proforma enclosed with NHQ Circular No. 219/2022 dated 11/11/2022 to the Jamboree authority on or before **25/11/2022**. No, further arrangements for buses for sightseeing can be made if the requisition is not received within the stipulated deadline.
6. **VVIP'S/DAY VISITOR:** During the State Day Celebration if any VVIP's/VIP's or day visitor from the States attending, list of such VVIP's/VIP's with name and designation is to be intimated to Rajasthan State by email at jamboreeoffice@bsgindia.org with a copy to jamboree@bsginidia.org by **10th December, 2022** so that the host state can initiate all necessary arrangements as per protocol.

The above is the decision of the SOC's meet decided unanimously which is meticulously to be implemented on priority basis pertaining to the participation in the 18th National Jamboree.
